Some data storage systems require isolation from their external environments due to security or regulatory reasons. These restricted data centers, called dark sites, contain storage systems that are isolated from the Internet and other networks (air-gapped) and are prevented from establishing any external connections.

In dark site scenarios any proactive monitoring solutions such as dial-home or Pure1® (the cloud-based as-a-service data-management platform from Pure Storage®) are not permitted. The only way to proactively monitor or validate an array is by visiting the site to carry out a visual inspection and monitoring.
