OFFICIAL TERMS & CONDITIONS**

NO PURCHASE NECESSARY. INTERNAL TRADE PROMOTION ONLY. NOT OPEN TO THE GENERAL PUBLIC. BY PARTICIPATING IN THIS PROMOTION, YOU AGREE TO THE FOLLOWING TERMS & CONDITIONS.

Sponsor: The Pure Storage Customer Awards Program (“**Program**” or “**Event**”) is sponsored by Pure Storage, Inc. (“**Pure Storage**,” “**Pure**,” and “**Sponsor**”), 650 Castro Street, Suite 400, Mountain View, CA 94041. Gift Item vendors are not sponsors of this Promotion.

Program Period: The Official Terms and Conditions cover the Program which begins December 1, 2022 and automatically renews annually until termination of the Program by Sponsor (“**Program Period**”).
