2. <u>Participation:</u> Use of this NASPO ValuePoint cooperative contract by all departments under the authority of Bloomfield Hills Public Schools are eligible to procure under this Participating Addendum.

3. Order of Precedence:

- 2. Minnesota NASPO ValuePoint Master Agreement No. MNWNC-125
- 3. The Solicitation including all Addendums; and
- 4. Contract Vendor's response to the Solicitation

These documents shall be read to be consistent and complementary. Any conflict among these documents shall be resolved by giving priority to these documents in the order listed above. Contract Vendor terms and conditions that apply to this Master Agreement are only those that are expressly accepted by the Participating Entity and must be in writing and attached to the Master Agreement as an Exhibit or Attachment. No other terms and conditions shall apply, including terms and conditions listed in the Contract Vendor's response to the Solicitation, or terms listed or referenced on the Contract Vendor's website, in the Contract Vendor quotation/sales order or in similar documents subsequently provided by the Contract Vendor. The solicitation language prevails unless a mutually agreed exception has been negotiated These documents shall be read to be consistent and complementary. Any conflict among these documents shall be resolved by giving priority to these documents in the order listed above. Contract Vendor terms and conditions that apply to this Master Agreement are only those that are expressly accepted by the Participating Entity and must be in writing and attached to the Master Agreement as an Exhibit or Attachment. No other terms and conditions

shall apply, including terms and conditions listed in the Contract Vendor's response to the Solicitation, or terms listed or referenced on the Contract Vendor's website, in the Contract Vendor quotation/sales order or in similar documents subsequently provided by the Contract Vendor. The solicitation language prevails unless a mutually agreed exception has been negotiated.

- 4. Participating Entity Modifications or Additions to Master Agreement:
- **A.** Approval of this Participating Addendum by Bloomfield Hills Public Schools will extend to any subsequent addendums/amendments of this executed Participating Addendum.
- B. Purchases are authorized only if a Bloomfield Hills Public Schools Purchase Order is issued in advance of the transaction. Purchase orders under this Participating Addendum shall be issued to an Authorized Reseller identified in Attachment 1. A Purchase Order must indicate that the ordering agency has sufficient funds available to pay for the purchase. Such a Purchase Order is to be provided to the Authorized Reseller by the ordering agency. Bloomfield Hills Public Schools will not be liable for payment for any purchases made by its employees without appropriate purchase authorization issued by the Bloomfield Hills Public Schools Purchasing Agent. If the Authorized Reseller provides goods or services without a signed Bloomfield Hills Public Schools Purchase Order, it does so at its own risk and expense.
- C. NONDISCRIMINATION: The Contractor warrants and represents that all of its employees are treated equally during employment without regard to race, color, religion, disability, sex, age, national origin, ancestry, marital status, familial status, sexual orientation, gender identity and expression, or genetic information.
