## AMENDMENT NO. 5 TO MASTER MNWNC-125, MN CONTRACT NO. 195192, RELEASE NO. C-871(5)

**THIS AMENDMENT** is by and between the State of Minnesota, acting through its Commissioner of Administration ("State"), in cooperation with NASPO ValuePoint and Pure Storage, Inc., 650 Castro Street, Suite 260, Mountain View, CA 94041 ("Contractor").

**WHEREAS**, the State has a Contract with the Contractor identified as Contract No. 195192, with a term beginning October 22, 2015 through July 31, 2022, to Computer Equipment; and

**WHEREAS**, Minn. Stat. § 16C.03, subd. 5, affords the Commissioner of Administration, or delegate pursuant to Minn. Stat. § 16C.03, subd. 16, the authority to amend contracts; and

**WHEREAS**, the terms of the Contract allow the State to amend the Contract as specified herein, upon the mutual agreement of the Office of State Procurement and the Contractor in a fully executed amendment to the Contract.

**NOW, THEREFORE,** it is agreed by the parties to amend the Contract as follows:

1. That Contract No. 195192 is extended through February 28, 2023, at the same prices, terms, and conditions.

This Amendment is effective beginning August 1, 2022, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Contract is canceled, whichever occurs first.

Except as herein amended, the provisions of the Contract between the parties hereto are expressly reaffirmed and remain in full force and effect.
