

**Participating Addendum Number 0705-23-PS
Amendment No. 1
for
COMPUTER EQUIPMENT, PERIPHERALS & RELATED SERVICES**

This Participating Addendum Amendment No. 1 (Amendment) to Contract #0707-23-PS (“Contract”), by and between the City of Falls Church (“Participating Entity”) and Pure Storage (“Contractor”) is made and effective this 14th day of May 2025.

WHEREAS, the Contractor is currently providing Computer Equipment, Peripherals & Related Services as ordered by the Participating Entity in accordance with the Contract; and

WHEREAS, Amendment No. 2 to the Master Agreement by and between the Contractor and the State of Minnesota has been amended effective June 20, 2025; and

WHEREAS, such amendment to the Master Agreement extends such term to June 30, 2028.

NOW, THEREFORE, it is agreed by the parties to amend the Contract via this Amendment No1 as follows:

- 1. That the Contract is extended to June 30, 2028, at the same terms and conditions.; and
- 2. That Exhibit D: Price Schedule, is deleted in its entirety and replaced with the attached “Exhibit D: Price Schedule, Amendment 2.”

This Amendment is effective beginning June 30, 2025, or upon the date that the final required signatures are obtained, whichever occurs later, and shall remain in effect through contract expiration, or until the Master Agreement is canceled, whichever occurs first.

Except as herein amended, the provisions of the Master Agreement between the parties hereto are expressly reaffirmed and remain in full force and effect.
